Attention Billers – Reimbursement Process:

In 2022:

- Claims/Encounters will be reviewed for processing on a **monthly** basis starting July 2022 *retroactively to Jan 1, 2022*
- Payment will be processed **monthly** basis effective July 2022 with an explanation of payment of claims submitted
- Timely filing and standard claims policies may apply

Beginning January 1, 2023

- Reimbursement will be administered through a standard biweekly claims payment process
- Practices continue to submit claims/encounters with appropriate coding
